Provides general information about elder abuse, a flow chart to respond to suspected abuse, and specific tips on what health care providers can do. It lists common signs and symptoms, answers commonly asked questions, and identifies interventions. ME.W811e

***Elder Abuse: Questions and Answers-An Information Guide for Professionals and Concerned Citizens***, Toshio Tartara. Washington, D.C.: National Aging Resource Center on Elder Abuse, 1992. This publication provides basic information in a question and answer format, including: the origins, causes and incidence of elder abuse on both the national and state levels; victim and perpetrator characteristics; and an explanation of the services available to victims, families and at-risk elders.
